



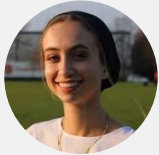

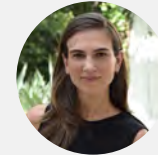
**Dounia Bourabain** *deferred 2020-21*

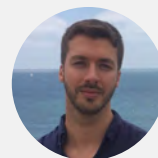
**Laure Primerano**

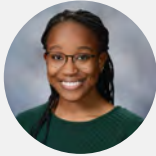


**Lukas Vanacker** *deferred 2020-21*

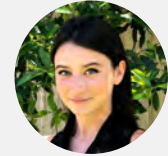
**Manuela Botaka**

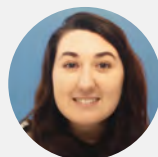
**Emily Hardick**

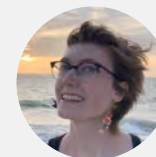
**Christopher Hebert**

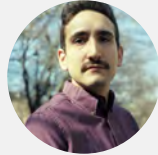

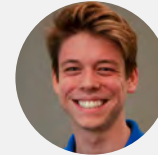
**Olivia Rastatter** *deferred 2020-21*

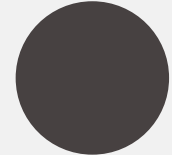
**Adam Sax** *deferred 2020-21*

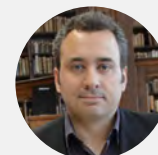
**Dr. Suzanna Charles**

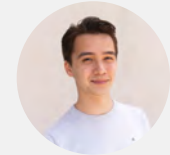
**Kim Greis**

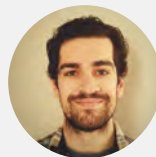


**Phillip Harter**

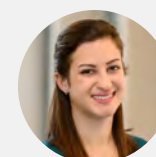
**Seyed-Sasan Mousavi-Vapouri** *deferred 2020-21*

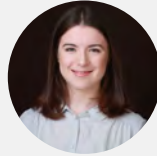

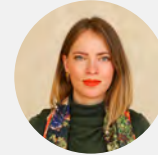
**Mariska Jung**

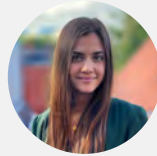

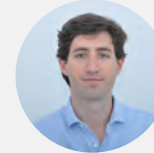
**Dr. Angeliki Paidakaki** *deferred 2020-21*

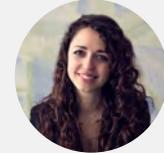
**Dr. Marta Vilar Rosales**

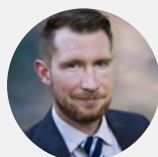

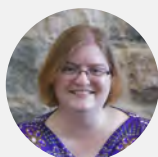
**Jhizet Panosian**

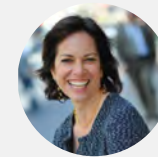
**Alex Engler**

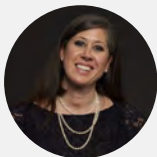
**Lisa Palmer** *deferred 2020-21*

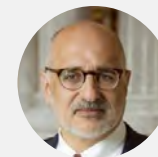
**Shea Rhodes Duca** *deferred 2020-21*
