He will work with scholars involved in a multinational European Marie Curie project, SMARTINCS, from Delft University of Technology in the Netherlands, University of Cambridge in UK, Politecnico di Milano in Italy, Valencia Polytechnic University in Spain, and Karlsruhe Institute of Technology in Germany.
